- > Blake welcomed Ken Adair, County of Wetaskiwin No. 10, Division 5 Councillor
- Motion to approve January 19, 2023 minutes made by Kevin Cummings and seconded by Kathie Drynan.
- > Treasurer report was given by Blake Bartlett in absence of John Hrynkow, Treasurer
- Blake thanked WLWLSA's Winter In-Lake Sampling crew, Kathie Drynan, Corey Drynan and Lincoln Drynan for successfully completing the winter program [4 dates x 2 locations per date]
- Blake brought forth the reasoning for revisiting the 2023 tributary sampling program. Enlight of proposed 2023 restoration programs within the Wizard Lake Watershed it was unanimously agreed that all ten tributary sampling locations should be sampled as in previous years to keep with the consistency of the data flow in subsequent years. The cost will be \$123.60 per site for lab costs. Donna Andres made a motion to do the 2023 Tributary Sampling program \$123.60 for 10 locations. Linc Drynan seconded the motion. Linc Drynan volunteered to pay for the 2023 Inlet Tributary Sampling lab services.

- Blake will present to County of Wetaskiwin No. 10 Recreation Board WLWLSA grant applications March 22, 2023 7pm. Funding model is 50% Wetaskiwin County/50% Leduc County. Ken Adair requested the breakdown for the 2023 grants being presented March 22, 2023.
